DATA CONTRIBUTION

- 1. Emory University ("Emory") and participating sites ("Contributors") are independent data controllers, each responsible for processing de-identified data at their respective institutions.
- 2. Emory will adhere to the Health Insurance Portability and Accountability Act of 1996 (HIPAA) when handling de-identified data.
- Contributors will adhere to the relevant health information security and privacy laws and regulations for processing de-identified data specific to their local context.
- 4. Contributors will ensure that approval or exemption from the local IRB/Ethics Committee is obtained before starting data collection.
- 5. Contributors will only provide de-identified data, meaning no patient names, dates of birth, or any potentially identifiable information.

USE OF DATA

- 6. Data will be used exclusively for OtoSurg 1 as outlined in the protocol and this agreement.
- 7. Data will not be utilized for any commercial, financial, or personal uses.

ACCESS TO DATA

- 8. Contributors will have access to data generated at their institutions and will grant Emory the right to use this data as described in the USE OF DATA section.
- 9. Contributors will not be able to access any data from sites outside their institution.
- Third parties will not be granted access to any data produced by the study.
- 11. Aggregate, anonymized results will be shared with the OtoSurg 1 network and in any publications by the OtoSurg 1 Team.

CONFIDENTIALITY AND SECURITY

- 12. All data will be stored through the secure Research Electronic Data Capture (REDCap) web application, as outlined in the protocol.
- 13. The study team, including Emory and all Contributors, will not re-identify any study participants.
- 14. The study team (i.e., Emory and all Contributors) will inform one another within two business days of becoming aware of any data security breach (e.g., unauthorized or accidental access, use, or disclosure).

AUTHORSHIP AND ACKNOWLEDGEMENT

- 15. The results of OtoSurg 1 will be published following international collaborative authorship and equity guidelines.
- 16. Contributors will be properly acknowledged in accordance with the study protocol.
